Dear Dr. Haar,

I am writing to provide you with an update on the Department of Commerce (Department) Energy Environmental Review and Analysis (EERA) staff efforts since the close of the Commission's public comment period (Notice of Public Comment Period, eDocket No. 20148-102194-01) on the *Request to Reconsider Establishment of an Advisory Task Force* for the great northern transmission line.

In response to EERA's request (*Request to Reconsider Establishment of an Advisory Task Force*, eDocket No. 20147-102144-01) that the Commission reconsider efforts to assemble an advisory task force (ATF) due to lack of sufficient participation to meet the statutory requirements of an advisory task force (Minn. Stat. 216E.08), the Commission opened and noticed a public comment period on the matter. The comment period closed on August 22, 2014.

Twenty-two comments (2 via edockets and 20 via the Speak Up forum) were filed; 7 of the comments were filed by one individual (Mr. Richard Libbey, Izaak Walton League). Mr. Libbey, on his own initiative, reached out to those local units of government (LUG) and non-governmental organizations (NGO) identified on the EERA's proposed ATF structure (EERA Comments and Recommendation – Application Acceptance, eDocket No. 20145-99563-01) in an effort to elicit additional participation on an ATF. Mr. Libbey's efforts focused on the eastern portion of the proposed GNTL route. Through Mr. Libbey's efforts, three additional LUGs and one NGO agreed to sit on an ATF (See Attachment A LUG/NGO Table).

The resulting complement of ATF candidates remains insufficient to meet the statutory requirements under Minn. Stat. 216E.08; however, there are other means by which to solicit input from those LUG and NGO representatives identified in the attached table. EERA proposes two options for the Commission's consideration: 1) Augment the continuing work with those individual LUG/NGO representatives as stated in EERA's August 8, 2014, request; and 2) the formation of an informal "working group." EERA's concept of each option is outlined below:

1. Individual Solicitation of Input. In this process EERA staff would continue to work with those interested LUG/NGO representatives previously identified (plus the new additions identified on the attached table) directly to assure that their concerns are recorded and considered, and assist them in developing potential alternative route segments should they so desire. This includes providing a cd of the complete HVTL Route Permit Application for their reference.

Augmentation of this approach would include:

- Providing those interested LUG/NGO representatives with a copy of the *Summary of Scoping* once it is completed (anticipated date of September 30, 2014). The *Summary of Scoping* document will include a description of the EIS scoping process, a matrix/table listing each commenter and their comments, and maps illustrating each alternative route segment or alignment modification put forth for consideration.
- Along with the *Summary of Scoping*, provide a Survey (similar to the attached example in Attachment B) to focus the participants on potential conflicts with, or issues relative to, regional and local planning for consideration in the scope of the environmental impact statement. A cover letter explaining the use of the survey, a review and comment timeline, and contact information to the EERA staff member to assist the LUG/NGO representative would be included.

EERA staff believes these efforts would have a minimal (2-3 weeks) impact on the anticipated EIS Scoping Decision release date of October 31, 2014, (ALJ First Pre-hearing Order, eDocket No. 20148-102112-01).

2. Working Group. This process would also begin with a telephone conversation to each person identified on the attached table (plus to each of the four original West ATF candidates) inviting them to join an informal working group. The proposed charge to the working group would be identical to EERA's original ATF charge (EERA Comments and Recommendation – Application Acceptance, eDocket No. 20145-99563-01) and the meetings would be accompanied with the similar support (i.e. EERA staff, applicant representatives and GIS facilities). The working group is anticipated to meet three times.

Assuming that the initial telephone conversations and mailings (including cover letter and RPA) are completed by September 19th, the first meeting occurring the week of September 29th (anticipating the second and third meetings during the weeks of October 20th and November 10th, respectively) and allowing two weeks to assemble the findings, EERA staff believes this would push the anticipated EIS Scoping Decision release date from October 31, 2014, (ALJ First Pre-hearing Order, eDocket No. 20148-102112-01) to late December.
